

ORDINANCE NO. 17-2017

**AN ORDINANCE OF THE CITY OF ELIZABETHTOWN, KENTUCKY
RENAMING RIGHT-OF-WAY OF THOMAS STREET AND STRAWBERRY ALLEY**

Whereas, the City of Elizabethtown has commenced a drainage and utility project in the area of the city along Strawberry Alley and Thomas Street; and

Whereas, the Elizabethtown City Council by official action on November 21, 2016 adopted Ordinance No 22-2016 which closed a portion of Strawberry Alley (Lane) to allow for the construction of a stormwater basin; and

Whereas, the stormwater basin construction has severed the street connections and street continuity of Strawberry Alley (Lane) and Thomas Street; and

Whereas, the City of Elizabethtown desires that the property in the general area of Strawberry Alley and Thomas Street is properly addressed to assure timely response by emergency personnel and to protect the public health, safety and welfare of residents in the area.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Elizabethtown, Kentucky that from and after the passage, approval and publication of this Ordinance, that a portion of the public right-of-way formerly known as Strawberry Alley or Strawberry Lane or Mock Alley or Thomas Street as shown in the Henry B. Helm's Addition be named Strawberry Alley and that a portion of the public right-of-way formerly known as Thomas Street or Middleton Alley or Strawberry Alley or Mock Alley as shown in the Henry B. Helm's Addition be named Thomas Street. See attached Exhibit No.1 as further illustration of this change.

BE IT FURTHER ORDAINED that street signs be erected indicating the street name for the entire length of these public right-of-ways so the properties along these right-of-ways may be properly addressed. The effective date for the change in addressing shall be January 1, 2018 to

allow notice to all appropriate agencies and property owners.

BE IT FURTHER ORDAINED that the Mayor of the City of Elizabethtown and/or her designate be and she is authorized and directed to take all steps necessary to perfect this Ordinance.
